Hospital Price Transparency Details Available at CMS.gov Website, AHA Resources Help Members Prepare

Details on the Centers for Medicare & Medicaid Services' hospital price transparency final rule can be found on the CMS.gov website [here](#). Issued Nov. 14, 2019, the CMS ruling requires hospitals provide an out-of-pocket price estimator tool or information on 300 "shoppable" services for patients as well as disclose their privately negotiated rates with health insurers, discounted cash prices and gross charges, which began Jan. 1. President Signs Medicare Sequester Relief Legislation

Update: President Biden April 14 signed into law legislation that would eliminate the 2% across-the-board cut to all Medicare payments, known as sequestration, until the end of 2021. The legislation also makes several technical changes to the rural health clinic provisions that were included in the Consolidated Appropriations Act, 2021. The House of Representatives last night voted 384-38 to approve the legislation, which the Senate passed last month. [Read more](#)

OSHHRA is represented at the national level by the American Society for Healthcare Human Resources Administration Region 5 Consultant Karyn Batdorf, CHHR, director of


Human Resources at Mercy Health in Cincinnati.
